I. General Terms of Delivery

1. In General

All our offers, performances, deliveries, sales or other transactions, including their providing, are considered under our following terms. Divergent terms, even in case they are declared as own terms of our trading partners, do not restrain us. Our pass over in silence facing diverge terms are not to mean in any case as an admittance and/or confirmation. By receipt of our order confirmation, latest after the receipt of the first furnished performance or partial performance, our terms of sales and deliveries are considered as admitted and all further trades as confirmed, if there is nothing different expressive in writing confirmed. Suspensions, alterations and/or complements of a contract and our terms have need of writing. Verbal confirmations including such of suspension of the need of writing, are ineffectual.

2. Offer, Order, Commission

Offers are without prejudice. All orders, mediate or immediate, need to be in writing for legal justification by us. Our order confirmation determines the content of the contract. Purchaser's opposing terms are of no validity. Fixed day orders are only valid, if they are expressly admitted as such by us. Besides that, details about deliveries are not binding. By publication of an order the purchaser declares his solvency. We are justified to incline the performance of the contract for a payment in advance. Or in case of not accomplishing a bail to withdraw from contract. Alterations or cancellation of orders are only possible by consultation with our suppliers and require our admittance within a suitable period. The additional expenses are the customers due. Devastation of fire, explosion, flooding, official mode of acting or other not foreseeable circumstances at our suppliers or suppliers for necessary materials needed for our products give us the rights to withdraw from contract without the obligation of a subsequent delivery or decrease the confirmed delivery quantity.

II. Liability of Defectiveness

In case of delivery of merchandise with recognizable or concealed defectiveness or for the miss of assured characteristic peculiarity we accomplish within 6 months from date of delivery to the customer in the manner warrant only as we choice, either to improve the merchandise free of charge or sending merchandise free of defectiveness as subsequent delivery. The customer grants us a suitable period of 6 weeks from the date of receipt his reprove of defectiveness for improvement or subsequent delivery. If we fail to improve the defectiveness or subsequent delivery within a suitable period, or in case we decline, the customer is justified to withdraw from the purchasing contract, to reduce the purchase-money or to convert the bill of sale.

2. Exclusion of Indemnification

Claims of indemnification by the purchaser because of positive offend against demand, guilt to the terms of an agreement or unauthorized acts are excluded, except they are caused by our self or one of our leading employee on purpose or coarse careless, or by means of infringement essential agreement obligations. In case of deficiency of an assured characteristic, performance postponement or impossibility under our responsibility an exclusion of indemnification takes not place. Besides that, for impossibilities which are not in our responsibility, any liability is excluded. As far we can be claimed of liability, in commercial business we are only committed to compensate the unforeseen loss by settlement of contract.

3. Agreements as well as purchases respective settlements by oral, telegraph or phone by our retailers or representatives are only justified by our confirmation in writing. Also need agreements which change in any way our terms of delivery and performance for legality our confirmation in writing.

4. Exclusion of the Right for Retention and Settling of Accounts

The purchaser is only justified to come important of the right to hold back against payable acquittance due, if the settling of accounts are undisputed or are definite legal determined. The purchaser may not be abdicated in favour of anyone else in case of deterioration, delay, impossibility under our responsibility or liability because of infringement essential agreement obligations without our expressive confirmation in writing.

III. Property Proviso Clause

1. We keep proviso of property at the delivered merchandises until the total payment of all outstanding claims as well as not yet arising claims regardless of which legal argument. The payment particular claims under a current invoice as well as dropping balance and their admittance does not touch the right of property proviso. For the purchaser it is prohibit before total payment of by us delivered merchandises to fasten these merchandises as strong to his real estate, so that they can only be removed by contemporary damages of their substance.

2. The purchaser is anytime justified under rule of business for further Alienation of by us delivered merchandises revocable in the skeleton of his Regular management. The purchaser has immediate notify us about a distress or any other prejudice our rights the claims out of the further alienation of by us delivered merchandises, the purchaser abdicates to us by now with all additional or creative rights. We accept this abdication now. The purchaser is justified and obligated to draw in the to us abdicated claims, as long as we have not revoked this authorization. The draw in authorization is extinguished, even without expressly revocation, if and as soon as the purchaser does not fulfil his obligations to us, or when he begins to come to indigence. The purchaser has immediately notify in writing, if information is required, to whom he has the merchandise alternated and which claims he has out of this alienation. Additional he has to supply us the necessary documents for importance the abdicated outstanding claims (especially the customer's list and so forth). We are justified to notify the buyers of the purchaser about the abdication of the claim to us by the purchaser and to draw in the claims. Is the purchaser with his payment obligations to us in delay or an essential deteriora-

tion of his financial positions takes place, or he gives offence to other contractual obligations, the total remaining payment debt is payable at once. In this case we are justified without prejudice our other rights, under preservation of the purchase contract, to demand the delivering up and collect the merchandise. The purchaser has no right of possession. We liable, that to us belonging property at the merchandise and to us abdicated claims by demand of the purchaser to transfer or abdicate back to him, if his value exceed more than 20 % as the value of the abdicated claims (including eventual interest and incidental expenses).

3. Duration of Delivery

Acceptances of delivery terms will possibly be followed, but they are regulary not binding. It is understood that they are kept save by ordering the merchandises to dispatch. Agreed delivery terms coming out of force, if the purchaser does not fulfil his contractual obligations. Instances of act of providence or such not be the coarse of the supplier appearing incidents, as for example ununsufficient delivery of our works as well as foreign works, of which our preservation of management depends, postulate without more ado corresponds a prolongation of the delivery terms. Such circumstances justify us thereon, complete or partially withdraw from the contract. The purchaser can claim in writing an explanation if we withdraw or we deliver within a suitable period. If we not announce thereto within 3 weeks, the purchaser is justified to withdraw from the contract. In case of delivery delay by us indemnification claims and each kind of penalty for breach of contract against us are excluded. Partial deliveries and partial invoices are admissible. A fixed transaction only means as agreed, when it is displayed expressly at the delivery terms by word "Fixed Transaction". In case of purchases on demand, the purchaser has to take over within 3 months. Between demand and preferred delivery dispatch has to be at least 1 month.

4. Dispatch

In case the merchandise is dispatched or send to the purchaser's place, the risk flows over to the purchaser, as soon as the merchandise leaves the works. Is the merchandise ready for dispatch and there is a dispatch postpone or the take over out of reasons, we can not hold responsible for, the risk flows over to the purchaser, as soon as our notification of ready for dispatch arrives. Of no importance is, if the dispatch is made from the destination or who sustains the dispatch costs.

IV. Terms of Payment

The amounts of invoices are payable post-free an free of costs as follows: a) the invoices are due after receipt, b) payment within 8 days with 2 % discount. In case of payments by bill of exchange, the purchaser pays the bank-rate costs. The granting of discount depends on fulfilment of the entire payment obligations of former deliveries. If our invoices are not fully paid within 30 days after receipt, we are justified to claim interest in the amount of 2 % beyond the actual federal bank-rate. The evidence of a higher interest damage keeps with proviso. Bill of change and cheque are no fulfilment by hand out but only after redemption. The acceptance of bills of exchange is expressive under our proviso. Payments to employees or representatives are only valid, when employees or representatives are justified by full power of authority for encashment.

V. Competency of Court and Place of Destination

The place of destination for payment and deliveries is the place of dispatch. For all arguments out of contracts among merchants, which are not members named under § 4 HGB, as also with legal persons of law applying to public bodies or with special capital of law applying to public bodies, even also for claims out of bills of exchange and cheques, which are given under such contracts, the first court of justice the Country Court Mannheim is authorized. For all legal demand-proceedings is also the County Court Mannheim authorized.

2. Distinct judicial Applicability

The relation between vender and vendibility are excluded under the law of the Federal Republic of Germany.

VI. Ineffectual Clause

Should one or several determinations in this commerce terms or a term in surrounding other agreements be ineffectual or become ineffectual, so it will not touch the effect of further and/or other terms or agreements. For such ineffectual term or agreement, the lawful determination will take place.
